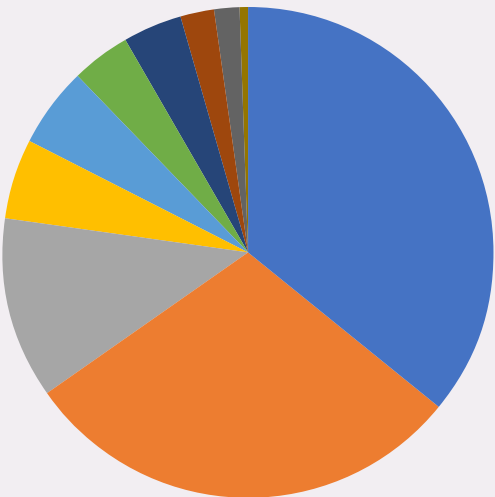

Grants Fill Critical Needs at Augusta Health

In 2021, Augusta Health Foundation made a difference in the lives of patients and employees by utilizing \$2,634,386 in grants that supported new and expanded care programs, new equipment, and technology. Each year, Augusta Health Foundation awards grants to departments and programs at Augusta Health that are designed to do two things: 1) improve the quality of care provided at the hospital and 2) improve the overall health of the community.

Grant funding is possible thanks to gifts from donors designated for specific projects or donated for unrestricted use through the Augusta Health Patient Care Fund. The Augusta Health Foundation Board awards grants based on the review and recommendation of the Foundation's Grants Committee.

Included here are highlighted grant programs for 2021.

Employee Emergency Fund

Since 2014, the Employee Emergency Fund has provided one time financial assistance to Augusta Health team members facing temporary hardship. In 2021, \$55,613 in funding was raised by team members and donors. Due to federal COVID-19 stimulus and relief programs offered, along with Augusta Health team member support programs, only \$3,000 was requested from the fund. These grants covered housing and utility assistance, unplanned medical procedures, and other emergencies.

Every Woman's Life Program

In 2021, Augusta Health became a provider for Every Woman's Life program (EWL). EWL provides important preventative procedures for underinsured and uninsured women in Augusta, Bath, Highland, and Rockbridge counties. 161 women were served in the inaugural year of the program.

Nursing Excellence Awards

Each year, Augusta Health recognizes outstanding nurses whose contributions to nursing fulfill the goals, mission, and vision of the Nursing Division. Award recipients model standards of compassion, care, and lifesaving work with Augusta Health patients. In 2021, three exemplary team members were awarded \$500 each towards educational and professional development.
